HOW DO I QUALIFY?

o LICENSE

Class A or B (with Air Brake Endorsement) Commercial Drivers License. Current Department of Transportation Medical Card.

O COMPLETED APPLICATION

Complete the driver application with accurate and honest information:

Omitted information can result in an immediate termination or non-hire.

Completed Independent Contractor Agreement and subsequent DOT required documents.

o GOOD DRIVING RECORD

We do check your MVR, so please list <u>all accidents and tickets</u>. We do not select applicants that have more than 3 tickets in the past 3 years. Applicants with convictions of DUI, DWI, or a C&I within the last 5 years will not be considered.

o REFERENCE CHECK

We will contact your past employers to confirm your employment history.

o DRUG SCREEN

You pay at the time that you take the screening.

We will reimburse you after you have driven for 30 days.

Positive drug screen results will be grounds for contract termination or non-hire.

ORIENTATION

Attend approximately a one hour orientation meeting either in person or on the phone.

THE QUALIFICATION PROCESS CAN TAKE UP TO ONE WEEK.

Time can vary depending on the holidays and time of year.

HOW DO I GET PAID?

The Contract Pay Rate =(# Miles) X (Pay Rate)

Example: Independence, KS to Covina, CA 1507(Miles) X .65 = \$ 979.55(additional examples available)

O Contract Pay Rate Determination:

Mileage is determined by the computerized mileage guide PC Miler.

Tow Car

Many drivers opt to own a tow car.

Fuel

We reimburse all fuel and DEF purchases used to deliver vehicles, whether you pay cash or purchase the fuel on credit and submit a receipt.

Reimbursements

We reimburse all tolls, fuel, layovers, permits, and incidental repairs such as bulbs, wipers, fuses, oil, etc with submitted receipts.

Advances

Trip advance available, fuel card program.



MORE ABOUT PAY

Settlement Periods- Pay is processed weekly. All paperwork received by noon on Friday will pay the following Friday. We offer payment by direct deposit.

Very Important! - In order for your settlement to be processed by our accounting department we must receive the following:

- Completed Bill of Lading
- O Daily Hours of Service Logs for all units-including all on duty, off duty, previous seven days, etc.
- Completed trip reports
- o Fuel Receipts (with trip envelope)
- o Receipts for reimbursable expenses
- O Completed Accident reports (If applicable).

As an Independent Contractor you will pay for ALL of your own necessities, such as:

- Food and hotel
- o Driving infractions and fines.
- O The transportation to and from the truck
- o Road service on vehicles that run out of fuel. Or DEF (Sometimes the fuel gage does not work, so it is your responsibility to stick the tank/ estimate the MPG.)

^{*} Incomplete paperwork will be returned to you for completion and can cause delay in processing-No Exceptions.

TRUCK DRIVER TAX DEDUCTIONS

The IRS allows truck drivers to deduct "ordinary and necessary" business expenses. This can vary even on an individual level, but some expenses are generally accepted.

- Truck Maintenance

If you pay out-of-pocket for truck maintenance and supplies, you may be able to deduct these costs. These expenses can include everything from oil changed or new tires to washer fluid and cleaning supplies. Keep in mind that double-dipping is taboo. If your lessor reimburses you, you cannot deduct it.

- Union or Professional Association Fees

If you pay fees as part of a union or trucking industry organization, you can deduct them from your taxable income.

-Uniforms/Clothing

Uniforms are deductible, but only if they are required and your lessor does not pay for them. This includes specialized work gear like protective gloves, goggles or boots. Cleaning expenses for your clothing are also deductible when you are away from home.

- Hotels

- Electronic Devises

If you have a cell phone that you only use for work, you can deduct associated costs from your tax return. GPS units and CB radios are also deductible.

- Travel Expenses

As long as you have a tax home, you can deduct expenses for overnight stays, including hotel rooms and per diem expenses. The standard mean allowance varies by location. However, truckers can take a higher special meal allowance because of the Hours of Service regulations. Check IRS Publication 1542 for current amounts.

- Work Related Fees

Several work related fees are tax deductible. They include, but are not limited to

- -Drug testing fees
- -Driver's license renewal fees
- -DOT physical exams
- -Sleep apnea study costs

Tax Advantages:

At year end we will issue a 1099 for all gross payments paid to you. Most expenses on the road are tax deductible with receipts. The IRS does allow up to \$63 per diem for meal and incidentals or \$189 for lodging, meals, and Incidentals, and 57.5 cents per mile tow car mileage deduction. (2017) Check with your tax preparer about the details of these and other deductions you may be entitled to such as phone bills, internet, home office deduction, and miscellaneous office equipment.



COMMON QUESTIONS

How does dispatch work?

At least once per day the office generates a list of pending moves. This list is emailed to all drivers. Simply contact dispatch via telephone and choose the trip you want. Dispatch is assigned on a first come first serve basis and changes daily.

Do you have a minimum activity policy?

We ask contractors complete at least one (1) trip every 30 days with a total of 1,000 miles, or we will cancel your contract. You may be eligible to reapply.

Where will I deliver to?

We are busy year round serving all 48 states and Canada. Drivers are expected to deliver to any of the 48 states. This ensures the best service to our customers.

What is your dress code?

We do not have a standard dress code. We expect you to have groomed hair and recently bathed (time spend in a hot vehicle can produce body odor, please manage your hygiene accordingly). The image you project reflects on you, Driveaway USA, Inc and the customer you are delivering for.

Do I need a cell phone, lap top computer, or a smartphone?

You will need a cell phone. You can purchase a prepaid phone at a low price at almost any Wal-Mart, Target and K-Mart stores. You do not need a lap top, but many drivers find smartphones to be convenient for log apps, email, and paperwork sub mission.

Do I need to log empty miles?

No, upon the delivery of a unit DOT will allow you to go off duty until your next trip, however, you are required to submit all off-duty logs to the company.

Can I get two loads that run together?

There are many times when dispatch will have multiple units to be delivered to the same destination.

Are there round-trip trips?

Yes, we occasionally have round-trip options. You will need to check with the dispatcher to arrange round-trips.
